## FROM NETWORKING TO EDUCATION/CLE CREDITS, THIS SUMMER'S PROGRAMS WILL HELP BUILD YOUR PRACTICE

## **Education events**

CAALA's Plaintiff Trial Academy has trained close to 400 CAALA members the art and skill of trial advocacy. Running through the month of May, this signature program provides trial lawyers with intensive training from the best trial lawyers in the country.
